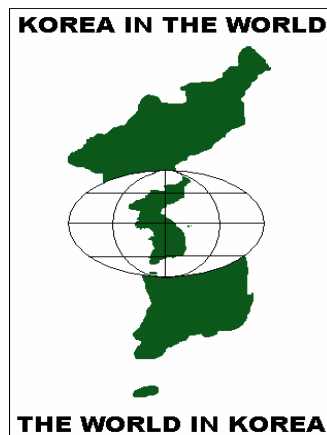

## **The Global Korea Award**

The Global Korea Award (GKA) was created by the Council on Korean Studies at Michigan State University in 1995 to recognize individuals or groups who have made significant contribution of cross-cultural understanding, global education, and well-being of Korean people around the world. The selection criteria for the award include:

- Demonstrated commitment and unselfish devotion to the well-beings of Korean community and global society,
- Significant contribution to the improvement of understanding between Korean and people around the world,
- Exceptional devotion to quality education for young generation in Korea and the world, and
- Outstanding achievement in scholarly and creative work that advances global understanding of Korea in the global community.

## **Profiles of the 2004 Award Recipients**

**JOHN CONYERS, JR.** Representative John Conyers, Jr., a Detroit Democrat, was re-elected in November 2002 to his 19th term in the U.S. House of Representatives. He has spent his entire career fighting for Michigan's working families. During the 107th Congress, Conyers introduced the "Military Tribunal Authorization Act of 2002," which provides lawmakers with an opportunity to exercise their constitutional authority to define and regulate the use of military tribunals. He is a Korean War Veteran, and worked hard for the Forgotten War Veterans (Korean War Veterans) to be listed as the Korean War Veterans Chapter among the Veterans for Foreign Wars (VFW), just like the Vietnam War Veterans and World War II Veterans. In addition, Mr. Conyers is the principal author of the "End Racial Profiling Act" and also introduced the "Hate Crimes Prevention Act." He is the recipient of many awards for leadership, including a Southern Christian Leadership Conference Award, which was presented to him by Dr. Martin Luther King, Jr.

**CHANG SOO HUH** Mr. Chang Soo Huh is Chairman & CEO of GS Holdings Corp. and LG Engineering & Construction Corp. He graduated from Korea University with a Bachelor's degree in Business Administration, and received an MBA degree from Saint Louis Graduate School. Mr. Huh began his career with LG Group in 1978 as a manager in LG International Corp. Since then, he has worked in the field of major strategy planning & evaluation within LG International & LG Chemical. He worked from 1982 to 1986 as Managing Director at LG International's Hong Kong

and Tokyo Offices. In 1992 he became Executive Vice President at LG Industrial Systems, and was appointed as Chairman of LG Cable in 1995. After working as Chairman of LG Cable for six years, he moved to his current post with LG Engineering & Construction in 2002. With the launch of GS Holdings Corp., a comprehensive holding company for LG Group's oil refinery (LG-Caltex Oil) and retail (LG Home Shopping and LG Mart) businesses, Mr. Huh assumed his current position and responsibilities as of July 2004.

**YOUNG WOO KANG, PH.D.** Honorable Young Woo Kang earned the degree of Ph.D. in Education from the University of Pittsburgh, Pittsburgh, PA in 1973 and an honorary Ph.D. in Literature from Yonsei University in Korea in 2003. He was a board member of the National Organization on Disability in 1995 to 2003, and since 1995 has been the Vice Chairman of the World Committee on Disability. Since 2001, he has been serving as Presidential Appointee for the National Council on Disability. He is also the Founding President of the Education and Rehabilitation Exchange Foundation, International. He is the author of *A Light in my Heart*, *There's No Mountain We Can't Climb: 10 Principles of Education for Success*, and *My Disability—God's Ability: 7 Principles of Triumphant Life*.

**MIKHAIL N. PAK (PAK CHUN-HO), PH.D.** Dr. Mikhail N. Pak is a Professor at Moscow State University and the Chair of History of Far East and South-East Asia at Moscow State University. He was born in Russia and received the degree of Ph.D. in History from Moscow State University. He was awarded various medals including the 7<sup>th</sup> Overseas Korean Compatriots' Prize (Science) by the Korean Broadcasting System (KBS) and The Knight of Science and Arts by the Russian Academy of Natural Sciences. He is the author of *History of Korea* and *History and Historiography of Korea*. He also translated *Samguk Sagi*, which was written by Kim Busik, to Russian.

**KOREAN MINJOK LEADERSHIP ACADEMY** The KMLA, established in 1996, is Korea's first coeducational preparatory boarding school designed to admit the nation's most gifted students and prepare them to attend leading universities in both Korea and abroad. The school has sought to combine a world-class education with a deep sense of reverence for Korea's 4,400 years of history, culture, and tradition. In 1998, KEDI (Korean Education Development Institute) nominated the KMLA as the Research and Development School for Gifted Education. The KMLA aims to provide the students with the academic tools necessary for excellence and leadership in their chosen fields, to contribute positively and proactively to the health and development of Korea, and to enable Korea to positively contribute to the development and progress of the world community.

## Profiles of the 2004 Special Tribute Recipients

**JOON S. MOON, PH.D.** Dr. Moon is Chairman of Mt. Rose Capital in the United States. After graduating from Michigan State University, he received a Ph.D. from University of California at Berkeley. In the International Studies and Programs (ISP) at Michigan State University, the Joon S. Moon Distinguished International Alumni Award was established to recognize international alumni who have brought special credit to MSU through their professional achievements.

**SANG-YONG NAM, PH.D.** Dr. Nam is serving as President of Supporting Committee for Center for Korean Studies at University of Michigan. He is Chairman of Nam Building Management Corp. and an adjunct professor of Yeonbun University in China. Dr. Nam earned Honorary Ph.D. from Choong Ang University in Korea. He has been contributing to the promotion of Korean Studies in the State of Michigan, making his efforts through the University of Michigan and Michigan State University.

**CHUL YOUNG KIM, PH.D.** Dr. Kim is President of Flying Korea Ltd. in Korea. He earned Ph.D. in Finance Department Michigan State University. Since 2004, he has been serving as President of the Michigan State University Alumni Association in Korea (MAAK). The MAAK, which provides a linkage between MSU and its alumni, has been working for enhancement of the image of MSU, and to especially promote Korean Studies at MSU, being working closely with the Council on Korean Studies at MSU.

**TAI SUNG KIM, PH.D.** Dr. Tai Sung Kim is Professor at Lansing Community College at Michigan in the United States. He graduated from the College of Law, Seoul National University. He earned M.A. and Ph. D. in Political Science from Michigan State University. Dr. Kim is the Director of International Programs at LCC. Since 1961, he has been made for the promotion of international understandings.

**JOHN RUSELOWSKI** Mr. Ruselowski is Chairman of Korean War Veterans Committee, City of Dearborn, Michigan. For many years, Mr. Ruselowski and his KWV committee members has been keeping commemorate the Korean War Armistice Day of July 27 of the year as Korean War Veterans Memorial and Korean American Re-Union Day in Michigan. As an active advanced laser technology engineer, he is eager to contribute to Korea and Korean American Business with his expertise in his field.

### **PURPOSE**

The Council on Korean Studies at Michigan State University was established formally in 1992.

The council's main objective is:

To stimulate interest in Korea among the people of Michigan and the United States,

To seek and provide information about the Korean cultural activities,

To exchange programs between Korea and the United States related to art, literature and science,

To help start and continue Korea-related programs at MSU and other American

Promote graduate and undergraduate education about Korea and related outreach programs.

### **MEMBERSHIP**

Membership is open to all people interested in Korean affairs. The president, the officers, and the Governing Board are elected by the members as specified by the Council's bylaws. There are five types of memberships: Corporate Member, Individual Life Time Member, Benefactor, Full Member and Associate Member.

### **ENDOWMENT**

The council established an endowment fund in 1992 to provide financial support for its activities.

The fund is administrated through the Asian Studies Center in consultation with the Council. A campaign is underway to raise \$2,000,000 in endowment.

### **PROFESSORSHIP**

Through funding from the Korea Foundation with a matching fund from Michigan State University, the Department of Political Science has established a Professorship in Korean Affairs, beginning in Academic year in 1994. The professor in this position will teach courses in Korean Affairs and organize various academic and cultural activities.

### **ACTIVITIES**

The Council has been actively engaged in organizing international conferences, holding a series of workshops and seminars, presenting several cultural events to introduce Korean culture to the large community surrounding MSU, and publishing some publications.
